EDITORIAL INTRODUCTION

The fictitious letter, signed Simon (Bar Kokhba, the Younger)^(1), was drafted for publication in Haaretz Newspaper but, in the event, happily perhaps, honest and vicious as it is, was not published. It is unashamedly pro-Israeli (as the law commands) and anti-Palestinian (as the law permits).

The article by Kobi Niv, a quote from which appears in the "Background", is real and was published in the Hebrew, but not in the English, edition of Haaretz. Simon's letter did, of course, not have footnotes and book references. We have added these to make our readers aware of the sources that Simon has been using.

It may be worth pointing out that, while Simon's letter is fiercely pro-Israeli and represents laudable views held by many (or most?) Israeli soldiers, settlers and politicians, there are some Jewish organisations which are, and were, opposed to the creation of the state of Israel and believe that we should **not** strive to make Jews safe and happy in **one** country (by killing and expelling its owners and original inhabitants) while allowing Jews to be persecuted and be unhappy everywhere else. Supporters of this organisation are called "the Bundists" and literature about them and their history can be found at the end of this letter. (2)

Kimmerling (2003) also seems to be fond of the disgraceful "Israelis" (they don't deserve the honour to be called "Israelis") who support, aid, assist, defend, and feed the people whom they ought to despise, hate, harass, oppress, exploit and eventually kill. Traitor Kimmerling starts his book as follows:

BACKGROUND

An exasperated Israeli journalist, Kobi Niv, expressed his frustration in a Hebrew article (omitted from the English edition of the newspaper) in Haaretz, 2018-11-28, entitled "From Task to Action: From Regularisation to Extermination". (My quote comes from Bresheeth-Žabner, 2020.)

1. C'EST LA LUTTE FINALE: THE LAST FIGHT

Dear Editor,

On 2018-11-28 you published a letter by my exasperated friend Kobi Niv. I profoundly sympathise with him. But now at last he can relax. His requests and prayers have been heard and soon the promised land will be free of the Arab vermin. For three years our foolish friends in the States, Britain, Germany and the EU have sent us billions of dollars worth of weapons and ammunition, enabling us to flatten Gaza, emasculate Iran, attack Syria (even though Syria had not attacked us), destroy the Syrian fleet, kill almost 60,000 civilians in Gaza, and now that the Arab vermin are exhausted, desperate, starving, begging for a single grain of rice, and will soon, absolutely all of them, die of hunger without us having to track them down, without a shot being fired, just by not feeding them, our foolish friends in the West grow all sentimental, feel sorry for the few stubborn Arabs who, sadly, have survived (but not sorry for the 60,000 they have helped to kill), feel sorry for the brats they have produced or who about to be born, and want us to feed them and stop our campaign and lose all we have achieved so far.

Why in Jehova's name! I say NO: C'est la lutte finale: The last fight. ^(4)

What was the point of bombing them, of killing 60,000, if we stop now just before the Endlösung ^(5) [Final Solution] has become a feasible reality! Why do they feel sorry for the Arabs who have survived till now and did not feel sorry for the 60,000 their ammunition and money has beautifully killed so far!

Killing babies and children by letting them die of starvation is an excellent idea. That's how you get rid of vermin, of fruit flies, rats and mice: remove their food sources, fill with cement the holes in walls they use to come in and out. It is a cheap (almost passive) way of getting rid of them.

If we let them grow up, they will be more expensive to kill, the boys will turn into terrorists and the girls will turn into breeding machines to produce more future terrorists. Killing pregnant women also is not perverse or inhuman but a splendid idea, because each of them is about to produce at least one future terrorist or breeding machine.

2. HOW TO UTILISE ARAB WOMEN

A good example, from 1948, of how to utilise Arab women is given by Michael Palumbo (bless him for publishing that example); therefore letting them die of hunger is comparatively humane: it is a "natural death":

"One Zionist soldier in Dawayma, 'prided himself upon having raped an Arab woman before shooting her to death. Another Arab woman with her newborn baby was made to clean the place for a couple of days and then they shot her and her baby.'" (Palumbo, 1989)

That situation is also vividly described in the novel "Minor Detail" by Palestinian novelist Adania Shibli: Original title "Tafāṣīl thānawī", a novel translated by Elisabeth Jaquette. New Directions Publishing Corporation, 2020. First published in Arabic in 2016 by Dar Al Adab: Beirut, Lebanon

3. LESSON EXCHANGE

This was a good idea, very economical, we learnt that from the Nazi death camps: first let them work for you until their strength is exhausted, then kill them and use their body parts (hair, teeth, skin) as raw materials, then burn them and use their ashes as fertiliser. This is called recycling: very progressive. "Waste not, want not," that's what I say.

But the Nazis also learnt something from us, the idea that it is possible to conceive of a race that is more valuable than all other races and is destined to dominate or exterminate them.

Our God told us, thousands of years ago (Deuteronomy 7:6), that we are his chosen people (superior to the non-chosen people) and should remove the original inhabitants from any land we wanted for ourselves by expelling or killing them (Well, now we want

Palestine and follow our god's advice, as we did formerly with the Philistines.)

On second thoughts: But, come to think of it, perhaps God's words about the chosen people ought to be translated or interpreted differently. That then would put Hitler into the wrong, but would also put our forefathers and my beloved modern leaders, the Zionists, into the wrong.

Hitler picked up this splendid idea from us (even though he was too vain, or too anti-Semitic, to give us credit for it). He declared that the Aryans are the supreme race (the chosen people) and therefore set out to remove all Jews from Aryan lands. A fair exchange of lessons. We learnt from each other: symbiosis!

Now we are trying it out on the Arabs. However, six million Jews murdered in the death camps is perhaps a rather high price to pay for an abstract lesson in race theory).

4.NEW JEWS

No, I say, do not listen to those sentimental idiots in Europe and the USA. We are the <u>New Jews</u> ^(6), we take by force what we want no matter who owns or inhabits it. We lie when it suits us. International humanitarian laws do not apply to us: because of the Holocaust (a blessing in disguise) we have absolute impunity. Anyone who is foolish enough to criticise Israel is anti-Semitic.^(7)

And, by now, we are so strong militarily that no state in the world is capable of "punishing" us or forcing us into submission.

We are now as strong as Hitler <u>wanted</u> to be: invincible. We are America's white "storm troopers" in the war against inferior races of the East, a white bulwark. That's why they are giving us unlimited support.

The Allies were strong enough to subdue strong Nazi Germany. But we are stronger and more ruthless than Nazi Germany, and nobody can impose his will on us.

Why are our supporters so squeamish now when they were not squeamish in 1948 (or after 7 October 2023)! They knew all along that our objective was (and has been since 1967, or even since 1895) not to destroy Hamas but exterminate all Palestians.

Our objectives are clear, but it will do no harm if I remind your readers of them:

THE WESTERN WORLD OWES US A DEBT

The Western world owes us a debt. That's why they have been sending us billions of dollars worth in weapons and ammunition to crush the Arabs - and now, all of a sudden, they call it "genocide". Well, it's their genocide: we are only "their willing executioners" (with apologies to Daniel Goldhagen ^(8)).

"The Western world,
which had long tormented and abused the Jewish people,
hastened to bless an event [the creation of "Israel"]
that saw an end to their victims' suffering.
A debt was to be paid.
Who was to pay it
and where it was to be paid
were not seen as of the essence,
so long as it was not paid by Europeans in Europe." ^ (9)

5. CLEAR THE PROMISED LAND OF EVERY ARAB

It has always been our intention to clear the Promised Land of every Arab: Do not let even one of them survive. ^(10)

Our enthusiastic supporters (who don't like the Arabs either) in the USA, UK, the European Union and Germany have always known that. They have given us billions of dollars in cash, weapons and ammunition (and moral support) to start, and almost finish, the job.

6. THE BLOODY BIBLE APPROVES OF GENOCIDE

The Bible says:

When you march up to attack a city, make its people an offer of peace. If they accept and open their gates, all the people in it shall be subject to forced labor and shall work for you. If they refuse to make peace and they engage you in battle, lay siege to that city. When the Lord your God delivers it into your hand, put to the sword all the men in it. As for the women, the children, the livestock and everything else in the city, you may take these as plunder for yourselves. And you may use the plunder the Lord your God gives you from your enemies. This is how you are to treat all the cities that are at a distance from you and do not belong to the nations nearby. However, in the cities of the nations the Lord your God is giving you as an inheritance, do not leave alive anything that breathes. Completely destroy them ... (Deuteronomy 20:10-17)

"Do not let them live in your land." (Exodus 24:33)

Every place where you set your foot will be yours: Your territory will extend from the desert to Lebanon, and from the Euphrates River to the Mediterranean Sea. (Deuteronomy 11:24)

This is the creed of settler colonialism ^(11), the root of the white man's philosophy, i.e. our philosophy, because we are white, we are the avant-garde of the white civilisers, the white Americans, the white Europeans, sworn enemies of the "barbarians" (since Grecian times), the white civilised people destined keep the hordes of Asian brutes and their "nations" in check and at bay. Our actions in Gaza show how civilised we are, because we proudly behave like civilised white people have proudly behaved all over the world since Columbus in 1492. That's why white people are so prosperous and educated today.

Land where non-white people live, Niggers or Arabs alike, is legally "terra nullius", land that does not belong to anyone, because non-white people aren't people. The white man who discovers it can take it, it now belongs to him, like any found object.

Back to Deuteronomy 11:24: similar sentiments are expressed in Exodus 24:23-33; Deuteronomy, 7:1-6, 9:1-5, 11:8-9, 11:23-25)

The Americans are a proudly Christian nation. Why do they want to stop us now? Do they not respect their **b**loody **b**ible?

7. THE VIRTUE OF ETHNIC CLEANLINESS

Here are some references which show that we always wanted to get rid of the Arabs in Palestine, all of them. And the world continued to aid us in our efforts, for many decades. Why should they fret now that at last we are about to succeed?

1895: Herzl's diary:

'We shall endeavour to **expel** the poor population across the border **unnoticed**, procuring employment for it in the transit countries, but denying it any employment in our own country,' (Pappé, 2006)

1917: Leo Motzkin:

Our thought is that the colonization of Palestine has to go in two directions: Jewish settlement in Eretz Israel and the resettlement of the Arabs of Eretz Israel in areas outside the country. The **transfer** of so many Arabs may seem at first unacceptable economically, but is nonetheless practical. It does not require too much money to resettle a Palestinian village on another land. (Pappé, 2006)

1948: Plan Dalet:

However, within a few months, yet another plan was drawn up: Plan D (Dalet). It was this plan that sealed the fate of the Palestinians within the territory the Zionist Leaders had set their eyes on for their future Jewish State. Indifferent as to whether these Palestinians might decide to collaborate with or oppose their Jewish State, Plan Dalet called for their systematic and total expulsion from their homeland. /../

These operations can be carried out in the following manner: either by setting fire to them, by blowing them up, and by planting mines in their debris) and especially of those population centers which are difficult to control continuously; or by mounting combing and control operations according to the following guidelines:

<u>encirclement of the villages</u>, conducting a search inside them. In case of resistance, the armed forces must be wiped out and the population expelled outside the borders of the state. (Plan Dalet, 10 March, 1948) (Pappé, 2006)

1948: Unbroken line:

"The exodus is nothing if not testimony to the endurance of a **vision** that runs in an unbroken line from the early days of Zionist colonization to this day." (Masalha, 1992)

"The idea has been considerably revived since the acquisition of what remained of Mandatory Palestine with its solidly Palestinian population, during the 1967 war. Over 200,000 Palestinians were driven or transported across the Jordan River in the wake of that war," (Masalha, 1992)

"As Ben-Gurion wrote in his diary on 12 July 1937: 'the <u>compulsory</u> <u>transfer</u> of the Arabs from the valleys of the projected Jewish state... we have to <u>stick to this conclusion</u> the same way we grabbed the Balfour Declaration, more than that, the same way we grabbed at Zionism itself."" (Masalha, 1992)

8. THE MOUSE TRAP

Now, at last, we have them almost crushed, displaced them dozens of times, their houses flattened, 60,000 of them dead, all of them starving, desperate for food, begging for mercy: what a joy to see the arrogant bastards in such a state!

And now we in our Solomonic wisdom, and with the help and approval of our American friends, have set up this new food distribution system, the <u>Gaza Humanitarian Foundation (GHF)</u>.

"Humanitarian"? What a joke! Let's call it the "Gaza <u>Humiliation</u> Foundation". Yes, it's sheer "Humiliation": they have to accept charity from us, and be grateful to us, who have created this misery for them. But when you are hungry, you can't afford to be proud. We have them under our boot, they have to lick out boot, hungry as they are.

But the GHF is an even smarter invention. It is manned by sadistic American security guards, Americans who sent us billions of dollars worth of weapons to crush the fucking Arabs. Now American citizens can join directly in the fu-fucking-fun, the fucking shooting sport with targets which look like humans, a bit emaciated though.

The GHF points are mouse traps. Mice are attracted by cheese. The silly little buggers think the cheese is charity. But when they come to get the cheese, the trap snaps shut: mouse is dead. Similarly the sacks of flour at the GHF points are bait to lure the Arabs. When they approach, we shoot them - fifty or a hundred every day. If we continue that patiently, eventually no Arabis will be left.

We don't have to go after them, no, they come to us to be shot. Hahaha! What a sport! Soon there will be no Gazans left to be

shot. Then our heroic snipers have to go to the West Bank for their target practice.

9. TRULY HUMANITARIAN

Some UN organisations have criticised the GHF for being inefficient and have claimed that the GHF does not deserve its name because it is not truly humanitarian.

Nothing could be further from the truth.

Admittedly, the GHF way of distributing food is inefficient.

But consider this: The purpose of a mouse trap, primed with cheese, is not to dispense humanitarian cheese to hungry mice but to attract mice who want to meet their maker.

Similarly GHF food is not meant to be distributed. It is bait. It is meant to attract hungry Palestinians so that our beloved snipers can shoot them.

So the GHF points do exactly what they are meant to do. They are very efficient.

They are also profoundly humanitarian because they free the lucky people who are shot from a future life-time of suffering.

Firstly they end all their current pain (as death does) and they guarantee that no such aches will hurt them in future, e.g. we save them the indignities and pains of old age: no more headaches, no more arthritis, no more incontinence, no more cancer, no more pangs of hunger, no more sleepless nights, no more worries, no more fear of bombs and drones, no more worries about children, parents or other relatives: a single bullet from one of our snipers cures all that.

Each Palestinian who dies instantly in this way should be grateful to the sniper who sent the saving bullet, call him his benefactor and saviour and pray for him: "Allah yi bariklak", if the sniper was a man, "Allah yi bariklik", if the sniper was a woman.

10. TWO-STATE SOLUTION

This is our concept of the two-state solution: Israelis on earth, Palestinians in <u>Jannah</u> (paradise). Obviously, modest and generous as we are, we have given our enemies the better option.

Quote: ... the Hagana's High Command, as part of the Consultancy, decided to ransack a whole village and massacre a large number of its inhabitants. At the time the British authorities were still responsible for maintaining law and order and were very much present in Palestine. The village the High Command selected was **Balad al-Shaykh**, the burial place of **Shaykh** Izz al-Din al-Qassam, one of Palestine's most revered and charismatic leaders of the 1930s, who was killed by the British in 1935. His grave is one of the few remains of this village, about ten kilometres east of Haifa, still extant today. (Pappé, 2006)

The Jews of the Old Yishuv had been treated by Palestinian Arabs with contempt. The new olim [immigrants] sought not only to re-create in Palestine an ancient polity but to refashion the Jews themselves. No longer abject victims, middlemen, peddlers, protected moneylenders, rootless, **soft-skinned intellectuals**, the Jews were to change into hardy, no-nonsense farmers, who would take abuse from no one. In their encounter with the new olim, the Palestinian Arabs often came face to face with, and were surprised and sometimes intimidated by, the "new Jews."

Though still a small minority, the settlers quickly began to behave like lords and masters, some apparently resorting to the whip at the slightest provocation. This was a major source of Arab animosity. Some Jewish observers saw it as the "new Jews" compensating for centuries of being at the receiving end of gentile violence. To the Arabs the insult and bewilderment were all the more severe in that the Jews had traditionally been seen as inferior, in terms of legal status and power, and as subservient, dependent, and weak. Benny Morris (2008):

Setting up settlements was a matter both of ideology and of strategy. Zionism from inception had held that agricultural settlement was the chief means by which the Jewish people would "return to the soil," fashion the "new Jew," and again become productive members of the family of nations. Settlement was also the means by which the Land of Israel would be "redeemed" from its centuries—old desolation and usurpation by foreigners. Last, the settlement grid would determine the envisioned state's contours and frontiers. Militarily speaking, the settlements, most of them kibbutzim, had proved their worth: they had successfully

Moshe Dayan (1915-1981): Israeli terrorist, military leader and politician:

Dayan's life and achievements took on great meaning for the Jewish people. Ronen Bergman (2018):
